

**Republic Shooting Range LLC**  
**Rules/Regulations/Policies/Procedures**

**1. LOADED FIREARMS**

Firearms are to be loaded only on a range firing line. No loaded firearms are to be left unattended for any reason. No loaded firearms are allowed inside the range house, restrooms, or in any parking area without expressly given permission by management. All firearms are to be cased or holstered in the clubhouse unless expressly given permission by management. No loaded firearms are to be left in any vehicle.

**2. SHOOTER RESPONSIBILITIES**

Participants are fully responsible for the actions of themselves and their guests.

Participants are fully responsible for their personal property and their guests' personal property. In no case will Republic Shooting Range LLC be responsible for the safety or the damage of any member or guest's personal property.

Participants are fully responsible for any children or pets. All pets must be on a leash and/or under control at all times. In no case will children be allowed on the property without adult supervision at all times.

**3. RIGHT OF REVOCATION**

Any participant, guest or person that fails to obey any safety rule, policy, sportsmanship rule, contest rule, training rule, or any other reason is subject to suspensions or revocation of their membership or range use rights. There will be no refund of any money, membership dues, fees, or deposits if any person is required to leave the property or any membership is suspended or revoked for any reason

**4. RANGE CLOSURE**

Republic Shooting Range LLC reserves the right to close the range to members for any reason deemed necessary. Republic Shooting Range LLC reserves the right to close any portion of the property at any time. Republic Shooting Range LLC will make all reasonable efforts to reduce range closings and to notify members prior to closing the range.

**5. MEMBER INFORMATION**

Republic Shooting Range LLC is committed to being an equal opportunity recreation and training facility. Republic Shooting Range LLC reserves the right to refuse the use of our facility to anyone based on known criminal history. Republic Shooting Range LLC also reserves the right to refuse the use of the facility to anyone with a known history of mental illness that is believed to be a potential threat to others. Persons who are forbidden by law from possession of a firearm will not be allowed on the property. Safety is our highest standard.

**6. DAMAGE TO RANGE PROPERTY**

Any member that is found to be intentionally destroying or damaging range property will face repercussions to include leaving the property, suspension or revocation of membership or criminal liability. It is also the member's responsibility to report any damage or destruction of any property. Members are fully responsible for the actions of their guests.

**7. UNSAFE EQUIPMENT**

Republic Shooting Range LLC reserves the right to forbid the use or discharge of any firearm, ammunition, archery bow, air gun, or any other property brought on the Republic Shooting Range LLC property which, in the sole discretion of Republic Shooting Range LLC representatives, is deemed to be unsafe.

**8. OBEY COMMANDS**

All participants and their guests will at all times follow the commands of the Republic Shooting Range LLC officials. All participants and their guests will at all times obey all posted signs, notices, and directives, including all traffic signs posted on the roadways entering and exiting the range.

**9. USE OF VERBAL COMMANDS**

All participants and guests are required to use verbal range commands. These commands are:

- "RANGE IS GOING HOT" - When loading and before firing firearm
- "RANGE IS CLEAR" - When your firearm is empty of ammo and made safe (cylinder open or slide locked back and magazine removed)
- "GOING DOWNRANGE" - When all firearms are empty and safe, announce command prior to walking downrange to check targets. No firearms handling is allowed while someone is downrange.
- " CEASE FIRE" - If at any time you see any unsafe act or action, stop shooting immediately and make firearms safe.

**10. RANGE ACTIVITIES**

All participants & guests who participate in any activity that is conducted on the Republic Shooting Range LLC property by Republic Shooting Range LLC or any other group is required to obey all range, match, club, contest, and safety rules.

**11. LOAN OR RENTAL OF RANGE PROPERTY**

Any range property loaned or rented to any participant or their guest is the participant's responsibility. The return, repair or replacement of this property is the participant's responsibility.

**12. AMMUNITION ALLOWED**

Reloaded ammunition is allowed. Republic Shooting Range LLC is not and will not be responsible for any damage to property or injuries to persons from the use of **any** ammunition. Tracer, armor piercing, incendiary, or explosive ammunition is prohibited. Participants utilizing the sporting clays target range, 5 stand clay target range and the guided hunt bird areas shall be restricted to the following shot size: No lead, tungsten, bismuth shot larger than #7 1/2, or steel shot larger than #6.

**13. FULL AUTO/SLIDE FIRE/BUMP FIRE/BINARY TRIGGER TANNERITE PROHIBITED** No full auto, slide/bump fire, binary trigger, rapid fire shooting or tannerite is allowed without expressly given permission by range staff. Only range staff approved targets are to be used on any of the ranges.

**14. EYE AND EAR PROTECTION IS REQUIRED AT ALL TIMES ON ALL RANGES**

**15. READ POSTED SIGNS AND ADHERE TO POSTED RULES**

I FULLY UNDERSTAND AND AGREE to the above terms and conditions and hereby submit this form to the Republic Shooting Range LLC for use of the facilities.

I FULLY UNDERSTAND that my use of the facilities is subject to suspension or revocation for violation of the above agreement. No refunds will be issued.

I FULLY UNDERSTAND that the use of firearms is inherently dangerous and I AM AWARE that being in the vicinity of firearms can result in injury or the loss of life.

I WILL FOLLOW ALL SAFETY RULES to assure a safe shooting environment for everyone.

I FULLY UNDERSTAND AND GRANT permission to Republic Shooting Range and its agents, employees, licensees, and successors to copyright, use and publish the likeness of myself and any of my guests. The likeness may be used or published individually or in conjunction with other photographs or videos in any medium and for any lawful purpose.

**16. WATCHED RANGE SAFETY VIDEO**

I agree that I have watched the Republic Shooting Range introduction safety video and any Republic Shooting Range video that is related to the shooting activity that I am or will participate in.

**17. CHANGES IN RULES**

I FULLY UNDERSTAND that Republic Shooting Range reserves the right to change or modify any rule or waiver at any time. Amended rules/waivers will be posted in the range house, on the website [www.republicshootingrange.com](http://www.republicshootingrange.com) and elsewhere on the property but the participant is responsible for knowing and abiding by current rules/waivers.
